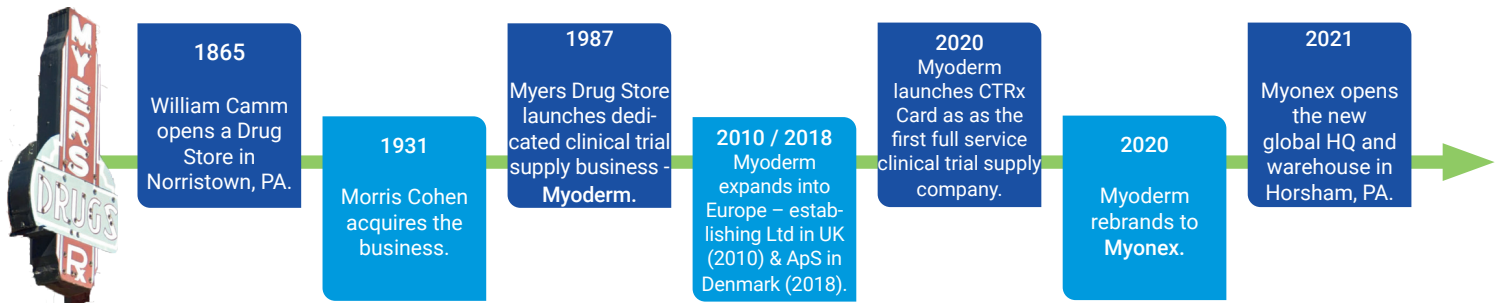

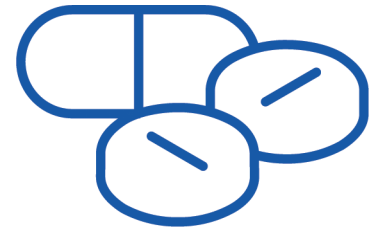

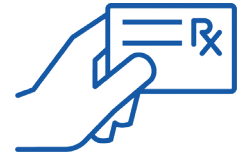

CASE STUDIES



Problem: No Access to LDD
(Limited Distribution Drug)

Our client needed a drug product that was very tightly controlled by the manufacturer and would not provide supply even with trial info: "There are other mechanisms in place for patients to receive this product". In addition, the clinical sites were also unable to supply.

Impact: Our client was conducting a 3-arm trial for one year without enrolling a single patient into this treatment arm



Solution: CTRx opened access to LDD through specialty pharmacy network

Using CTRx and with access to our specialty pharmacy network we were able to have the LDD shipped to the clinical site

Result: Allowed the Sponsor to enroll patients into the 3rd arm and continue the trial.

Problem: 30% overage at a cost of \$6.5MM

Global phase III trial:
US arm with 200 patients and 25 sites planned trial with PD1 combo – Pembro / Keytruda (8 cycles p/m)
Sponsor and CMO had planned for 30% overage – equivalent of ~1,500 vials / \$6.5MM / full GMP labelling process
CTRx alternative: set up with central model, direct to site relatively short expiry, open label
Impact: Overage would cost them \$6.5MM

Leveraging CTRx

Leveraging Myonex CTRx, the client is projected to save approx. \$6.5MM

Problem: Phase IV DTP

Client wanted a Direct to Patient (DTP) Solution for a phase IV trial using their own drug approved drug product.

Impact: Significant logistics cost and resources needed to manage supply

Solution: Pharmacy pick up or product delivered to patient

Using CTRx and our pharmacy network (Central Pharmacy and Retail Pharmacy Network) patients were able to pick up prescription at local pharmacy or have product delivered directly.

Result: Saved Client \$20+MM plus provided patients flexible options for receiving medications.
