## Dynamically growing exports

The value of Polish exports in the pharmaceutical industry in 2022 was €4.4 billion, recording an increase of more than 50% over the previous year.

Poland was the 22nd pharmaceutical exporter in the world, with a share of 0.5% in 2022. The Polish biotechnology and pharmaceutical industries are experiencing one of the most significant economic growth rates among European countries.

## Highly qualified staff

More than 38 institutes of Higher Education in Poland provide biotech-related degrees

1st in the CEE and 5th in all of Europe - Number of graduates with biopharma-related degrees

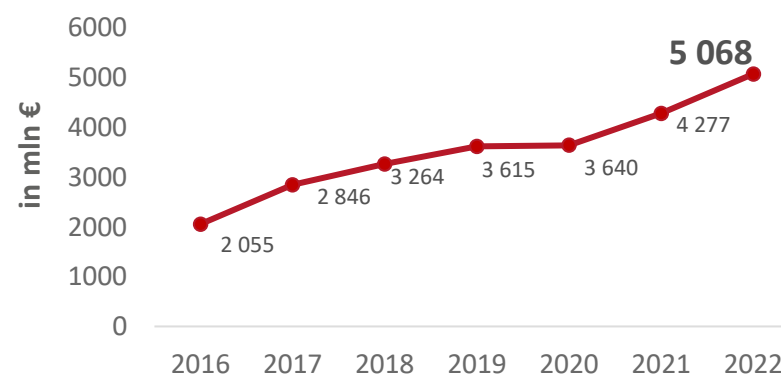

## The strategic importance of the medical device sector

The total export value of Polish medical devices and equipment sector amounted to **over €5 bn** in 2022.

Poland's medical devices constituted just **over 1%** of the country's total exports in 2022.

# WHAT MAKES US DIFFERENT

## Excellent quality

The Polish medical equipment and devices sector is known for:

- high quality,
- low failure rate,
- the low costs of operation, service and spare parts,
- high durability,
- compatibility with equipment made by other manufacturers
- excellent quality-to-price ratio.

## Long scientific tradition

Physics, medicine, chemistry, pharmacology and pharmaceuticals, alongside mathematics, are the highest-ranking scientific fields in Hirsche index for Poland. Alongside a dynamic IT sector, this provides a good foundation for the development of medical technologies.

Through institutions such as NCBR, PARP or PFR Ventures, Poland also offers various forms of financial and non-financial support to medical start-ups. In fact, 25% of venture capital in Poland was allocated to businesses from the Health Care sector.

## A dynamic startup ecosystem

- 13% of all startups in the country are in the medtech sector, which it turns out more and more entrepreneurs are investing in.
- Over the past few years, Polish start-ups, from the telemedicine sector, have targeted the AI, machine learning and medical devices sectors.

## Talent pool

Poland is home to world class pharmaceutical specialists and a large pool of talented scientists. This being one of the country's key assets when attracting foreign investors from the medical, biotech and pharma sector.

## Strong cooperation

Polish companies actively participate in international events (CPhI, BioConvention) and co-created BioForum ([www.cebioforum.com](http://www.cebioforum.com)) – a Central European cooperation platform for biotech and pharma companies.

# DID YOU KNOW THAT



## AI in radiology

The Polish company BrainScan created a tool that aids radiologists in making the preliminary diagnosis thus minimising the risk of misinterpretation of test results. The AI employed by Brain-Scan makes the correct diagnosis in 9 out of 10 cases, whereas radiologists can make mistakes in up to 15%.



## A revolution in the care of wounds

A Polish start-up has patented SmartHeal. Thanks to their special wound dressing, the healing process is significantly shortened. The dressing has a special electrochemical sensor which detects changes in pH value – thus indicating inflammation. The sensor provides the patient or doctor with information on the progress of treatment. The project won the prestigious James Dyson competition in 2022.



## Data-driven medicine

The medical start-up market is one of Poland's fastest developing areas. In recent years it has been characterized by rapid development and growing potential, especially in the area of medical innovation. In addition, according to the "Top Disruptors in Healthcare 2022" report, as many as 47% of start-ups participating in the survey say they are developing their company in the area of artificial intelligence and machine learning.



## Specialised equipment

Two categories account for the vast majority of Poland's medical device industry's exports, namely „orthopedic equipment, apparatus, prostheses, and hearing aids“ is one, while „the medical and veterinary instruments“ as the other. They accounted for €2,032 mln and €1,343 mln worth of exports, respectively in 2022.



## Polish Champion

The Polish company Adamed, is one of the largest Polish innovators as reflected by the sheer number of their patent applications. According to the EPO Patent Index, Adamed is at the forefront of Polish applicants. The company in total owns almost 200 patents in most countries of the world.

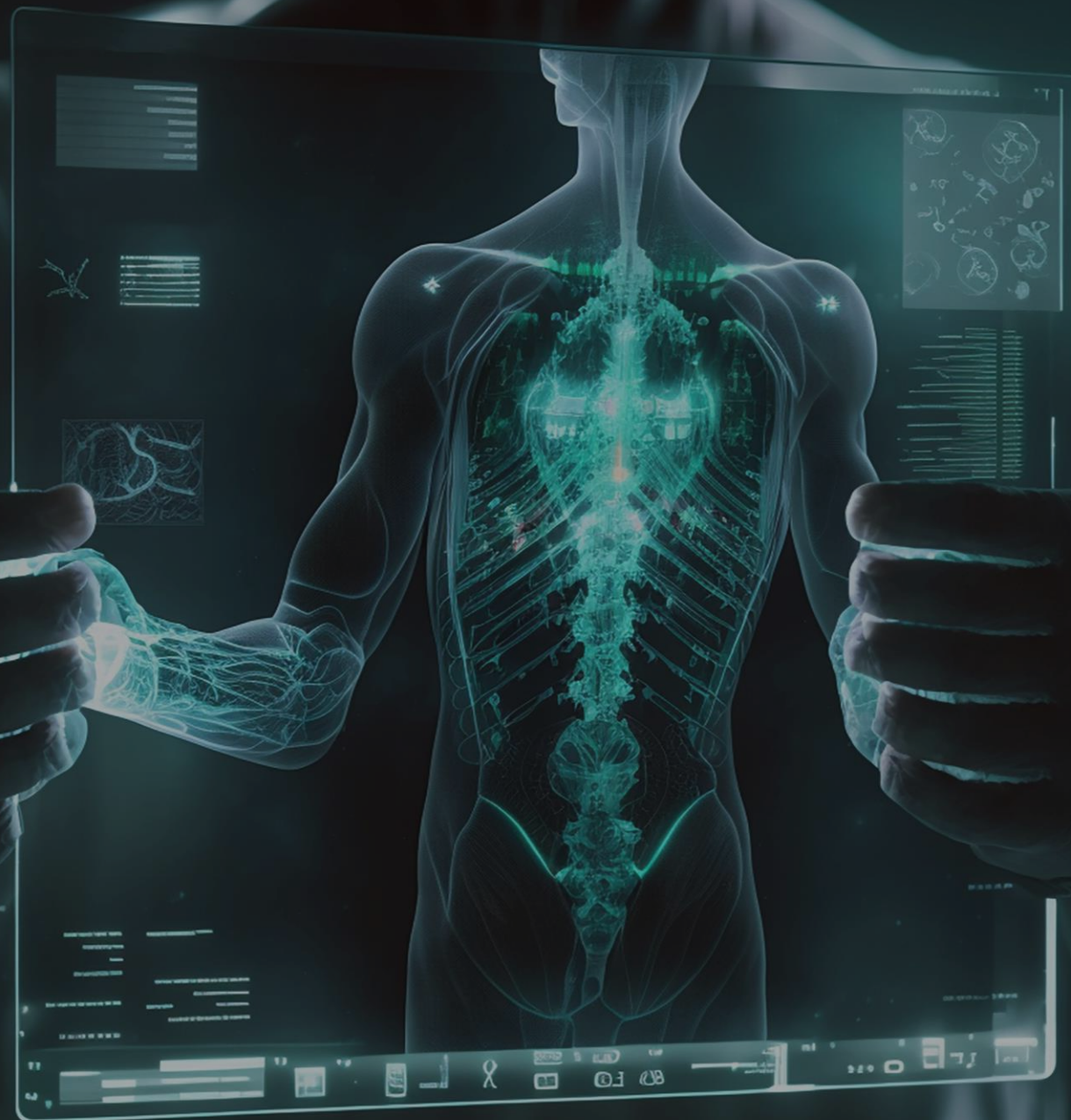
